SECTION 4: First aid measures

4.1. Description of first aid measures

General information

In the case of accident: Contact a doctor or casualty department – take the label or this safety data sheet. The doctor can contact The National Poisons Information Service: Dial 0344 892 0111 (24 h service). Contact a doctor if in doubt about the injured person's condition or if the symptoms persist. Never give an unconscious person water or other drink.

VInhalation

Bring the injured person into fresh air. Make sure the injured person is continuously monitored. Prevent shock by keeping the injured person warm and calm. If breathing ceases, give mouth-to-mouth resuscitation. If unconscious, roll the injured person into recovery position. Call an ambulance.

Skin contact

▼4.2. Most important symptoms and effects, both acute and delayed

SECTION 5: Firefighting measures

5.1. Extinguishing media

Recommended: alcohol-resistant foam, carbonic acid, powder, water mist. Waterjets should not be used, since they can spread the fire.

5.2. Special hazards arising from the substance or mixture

If the product is exposed to high temperatures, e.g. in the event of fire, dangerous catabolic substances are produced. These are: Carbon oxides. Fire will result in dense black smoke.
